# 2. General update on technical items

- 2.1. Grant Agreement Robert Otok explained some of the administrative delays with signing of the Grant Agreement. Original Project start date was expected in mid-November. Grant Agreement has now been signed between ASPHER (on behalf of beneficiaries) and EACEA. - 2.2. Pre-financing of project still awaiting final approval of 3<sup>rd</sup> party financial guarantee provided by BGU. Breakdown of payments:
  - 50% at start of project
  - 40% at end of year 2
  - 10% upon completion of project

  - Try to work within 10% budget flexibility that does not require EACEA approval when making adjustments

# 1. Opening of the Meeting

- 1.1. Welcome from ASPHER President John Middleton
- 1.2. Review of Project Aims and Objectives and brief introduction to partners by Lore Leighton
- 1.3. Address from Ted Tulchinsky on history and direction of the project and the importance to have good quality control with emphasis to refer back to the evaluation reports of Schools of Public Health by the Israel Council on Higher Education.
- 1.4. Address from EACEA Project Officer, Luigi Saia
  - Luigi Saia thanked the consortium for the invitation to speak
  - He congratulated SEEEPHI for being selected, noting that all partners can be proud to be amongst 10% selected
  - He has a sense of feeling of a solid partnership within the consortium with good atmosphere and relations success will depend on everyone
  - His role will be to assist, not to control
  - He provided some tips for success:
    - Have good relations with good partnership agreement and transparency
    - Have good quality plan
    - With final report EACEA will look for results make all efforts to achieve objectives
    - $\circ~$  Have a dissemination plan from the beginning
    - Keep reports simple and clear

- Keep in mind that Israel is the beneficiary of the action maintain aim and balance
- Be sure to have impact at instate
- Keep good relations and sharing with non-academic labour market
- The partners stressed the urgency to transfer the prefinancing budget in order to pay staff for preliminary work packages.
  - $\circ~$  Luigi Saia assured that he was following up on the prefinancing situation every day
  - He suggested that the start date could be delayed with a request for extension of the project if needed.
  - He advised also to be in touch with Dina Gallera ERASMUS contact point in Israel for dealing with any legal <u>and tax</u> issues.

- Appointment of Nadav Davidovitch and Kasia Czabanowska as focal points for Israel and EU were confirmed (Article 3.2)
- Explicit language on Partners contributing 10% additional resources was added (Article 4.3) – note: this can be in kind staff hour contributions
- Payment arangements (article 5): 25% of each partner's share of the prefinancing will be made up front. Balances will be paid upon justification of the progression of the project work and subject to the availability of the funds in order to maintain liquidity and allow for smooth progression of work.
