MESSAGE FROM THE PRESIDENT

Acceptance Speech of new ASPHER President Carlo Signorelli, given during the handover of the presidency in Sofia, Bulgaria on the occasion of the ASPHER Deans' & Directors' Retreat.

It is a great honour to assume today the presidency of the oldest European Public Health Association, founded in 1966. The honour is even greater to participate in the handover of this presidency in such a representative meeting; and in this regard, I take the opportunity to thank and congratulate Karolina Lyubomirova and the founding dean of the Sofia MU-FPH Prof. Vodenicharov for their excellent organisation of the 2022 Deans' and Directors' Retreat. The Retreat is back in person after 3 years; with the last edition hosted by the Italian Schools in Erice, Sicily – in May 2019.

My warmest thanks go to John Middleton who adeptly led ASPHER over the past 3 years – stimulating multiple initiatives involving various public health schools among our well over hundred members. ASPHER's activism has not gone unnoticed and the presence here in Sofia of Laura Magaña from ASPPH, Bettina Borisch from WFPHA, Natasha Azzopardi-Muscat from WHO Europe represents a clear proof of this. I express much appreciation for your presence here in person.

The ASPHER presidency returns after many years to a member from southern Europe and one of my targets is to increase involvement of the schools of public health of the Mediterranean area – starting with Italy. These schools have different structural characteristics (some of them are small) but are great resources with experience and professionals that can enrich our activities. In this regard, together with the excellent and efficient office in Brussels (thanks Robert and Lore), we will implement communication channels with the member schools to keep them connected, involving them to a greater degree in the strong initiatives that led, during John's presidency, to the drafting of valuable scientific positions and relevant papers.

With the rising complexity and volume of global public health challenges, it is paramount for public health professionals to develop new competencies and innovative approaches to prevent crises and minimize their impact. This ambition is achievable through the advancement of education and training. Higher education institutions in the European Region and in other areas of the world must look beyond national borders and engage in networks for education, research and practice.

Dear colleagues, it will be very difficult for me to match John's achievements as ASPHER president. However, I assure my commitment, the close relationship with member schools, the continuation of the precious scientific activities in progress. But I ask John, in the new role of vice-president and immediate past-president of the Association, for his concrete help in future activities as a sign of the continuity that we wish to provide with this handover here in Sofia.

There will be many opportunities to meet each other, hopefully more frequently than in the years of the pandemic, and to be able to discuss how to make ASPHER even more present in initiatives concerning public health, with particular regard to training, and participation in research projects, some of which are underway and will be presented in this retreat. 2023 will be a year with three major scientific events in which ASPHER will play an important role: the World Congress on Public Health in May, the September Deans' and Directors' Retreat in Dublin

(which I am sure will be impeccably organized by Executive Board member Mary Codd) and the annual European Public Health Conference.

Connections with other regional associations – starting with ASPPH, with WFPHA, EUPHA, IANPHI and others will be fostered and implemented. But I want to close by saying to all the deans and directors present here in Sofia – and connected via the web – that your role after the pandemic will be ever greater and more appreciated in your organizations and you will always be able to consider ASPHER as a partner to support your activities.

We already mentioned the [WHO Public Health and Emergency Workforce Roadmap Steering Committee meeting](#), but ASPHER attended several high level meetings in the past month including the [World Health Summit](#) and the [G7 Second technical meeting on the Public Health Emergency Workforce](#). It is important to contribute the schools' perspective for these key international discussions and make sure that public health education, training and research engages with public policy and remain high on the agenda of decision makers.

On Saturday at EPH, ASPHER Fellows Rana Orhan and Tara Chen and ASPHER's new Senior Lead on Climate and Health, Laurent Chambaud will participate in the [round table on 'climate emergency, health and equity education: policy and practice recommendations for Europe'](#).

ASPHER Task Forces continue to advance with the [Covid-19 Task Force session at EPH](#) and new publications and a second webinar series from the [Task Force on War](#). Be sure to read ahead to see what they have on offer.

Health impact assessment (HIA) is a process, which systematically judges the potential, and sometimes unintended effects of any new proposal (policy, project, program or strategy) on the population health, and the distribution of those effects within the population. The workshop intends to analyse different experiences in Europe regarding the role of PHIs and academia in overcoming reported existing barriers, and reach more sustainable and healthy societies. Climate change continues to be the biggest challenge of the 21st century, with profound and growing negative consequences on public health. This workshop will explore how different actors from inside and outside the public health domain can contribute to climate mitigation and adaptation actions. The discussion will cover: investing in climate-health training for public health and healthcare professionals; investing in public health research; designing and monitoring mitigation programmes; building climate-health-equity literacy; and providing space for dialogue for those communities who will be most harmed by an inadequate public health response. From a policy perspective, the workshop will help prepare recommendations for actions related to COP27 and will reflect on strategic processes taking place at the European level.

European national public health agencies have been pushed to their limits and currently face an urgent need to be renovated incorporating innovations in surveillance, communication and knowledge translation. The objectives of the workshop are:

- To discuss key innovations to implement in national public health agencies to improve surveillance, communication and knowledge transfer to policy makers and citizens.
- To reflect on supranational European coordination mechanisms that would allow for efficient surveillance and a rapid and adequate response to different public health challenges, including social inequalities in health.
- To manage public health intelligence in the European Health Data Space and the role of public health in this data lake design.

Saturday 12th November, 13:50 - 14:50, Alpha 6 - Round table: From Science to Policy Making: Lessons learned from ASPHER's COVID-19 Task Force

ASPHER convened a COVID-19 Task Force (TF) at the start of the pandemic involving over 60 experts, 30 member schools, more than 20 countries across four continents, supported by young professionals. Drawing on members' collective knowledge and expertise, the TF produced a significant body of work that speaks to different public health aspects of the pandemic and gaps in responses.

The panel will reflect on key lessons learned over two years of TF work and reflect on how to set-up, build, scale-up, and sustain collaborations with wide geographic, cultural, linguistic, and political-administrative coverage to support the capacity and preparedness of public health institutions during future challenges.

The 2022 Europe report of the Lancet Countdown on health and climate change: towards a climate resilient future

The 2022 report of the Lancet Countdown is published as the world confronts profound and concurrent systemic shocks. Countries and health systems continue to contend with the health, social, and economic impacts of the COVID-19 pandemic, while Russia's invasion of Ukraine and a persistent fossil fuel overdependence has pushed the world into global energy and cost-of-living crises. As these crises unfold, climate change escalates unabated. Its worsening impacts are increasingly affecting the foundations of human health and wellbeing, exacerbating the vulnerability of the world's populations to concurrent health threats.

ASPHER TASK FORCE ON WAR

Publications from the Gdansk seminar on ‘War in Ukraine and Public Health’

This [publication series](#) is being published several months after the start of the new and highly devastating phase of the Russia–Ukraine war. This war began already in 2014 in a hybrid form, but on 24th of February 2022, with the brutal Russian aggression on Ukraine, it moved into the phase of open military conflict, with clashes (especially in the eastern and southern territories of Ukraine) resembling those of the Second World War. The reactions of other states and societies have been very diverse worldwide. Nevertheless, the war in Ukraine has become a crucial topic of interest for many stakeholders. The impacts of this war are multifaceted, they must and they do concern the whole world. It is for these reasons that the current issue of the Journal focuses on the Russia–Ukraine war.

The starting point for this set of materials was a critically important seminar titled “War in Ukraine and Public Health,” organised in a hybrid form on 20th of May 2022 in Gdansk by the Medical University of Gdansk together with ASPHER. The five hour audio-video recording of this event is [available on YouTube](#). Due to the high importance of the topic, the participants of the seminar were asked to prepare written materials, which could be disseminated to a wider audience through the Journal. Some papers have taken the form of conference proceedings or commentaries, while others have been shaped into scientific papers. Altogether, they form a differentiated and important picture of the ongoing war in Europe, together with its consequences for the entire world.

WHO Public Health and Emergency Workforce Roadmap Steering Committee meeting



ASPHER immediate past-President John Middleton headed to Geneva immediately after the Deans' & Directors' Retreat for the [WHO Public Health and Emergency Workforce Roadmap Steering Committee meeting](#) from 17-19 October. He was there along with Laura Magaña, President of the Global Network for Academic Public Health to represent the schools of public health perspective.

The Steering Committee will advance workstreams on essential public health functions, competency-based education, mapping and measurement, and coordination and communications, in addition to roadmap governance and alignment with global health architecture. Participants will identify opportunities for action and next steps to move toward implementation of the roadmap.

The meeting was helpful in giving clarity to some of the objectives needed if all countries are to achieve a higher level of assurance against new public health threats, and to enable them to commit to the wider goals of improving the health of the people they serve, in the context of a need for a One Health and Planetary Health approach. The meeting also marked the launch of an action plan for concerted action by countries through to mid 2024.

G7 Second technical meeting on the PH Emergency Workforce for Predictable Rapid Response as part of the Pact for Pandemic Readiness



While ASPHER leadership was in Bulgaria for the Deans' & Directors' Retreat. Prof Wilm Quentin from the Berlin School of Public Health kindly stepped in to represent ASPHER at the G7 Second technical meeting on the Public Health Emergency Workforce for Predictable Rapid Response as part of the Pact for Pandemic Readiness in Berlin from 14-15 October.

Following up on the commitments of the G7 Health Ministers' Communiqué, the German G7 Presidency organized the meeting alongside the first meeting on Collaborative Surveillance in order to compile a general roadmap for G7 coordinated action under the [G7 Pact for Pandemic Readiness](#).

The objective of this second technical meeting was to create a common understanding of the major actors in the field of predictable and rapid response as well as the Public Health Emergency Workforce. It sought to identify current gaps in the landscape and together with key stakeholders define concrete action items to implement the G7 Pact for Pandemic

Readiness. Following the concept note of the Pact for Pandemic Readiness, the meeting discussed how to support well-trained Readiness groups and outbreak investigation missions.

The aim is to develop actions on how to better support national, regional and international outbreak response structures, which can be part of the roadmap. These actions should also be considered in the context of support of at least 100 LMICs to implement IHR core capacities.

UK Faculty of Public Health Report: Variability in public health ethics education across Europe

The professional discipline of public health is driven by its values. Public health is not just a technical discipline concerned with statistics or facts. Our norms, values, beliefs and the way we see the world, as individuals, communities and institutions which serve us, do matter and fundamentally affect our decisions, behaviours, policies, and practice. The ability to be aware

and reflect on norms and values when taking decisions, is a decisive professional virtue in public health practice.

Public health professionals face decisions that have far-reaching ethical implications. Despite this, the field of public health ethics is relatively new, and teaching and training in ethics for public health professionals is “highly variable in quantity and content” (Doudenkova et al. 2017). Building on a prior body of research, surveys of ASPHER and EUPHA members were undertaken to explore current levels of ethics education.



Book Launch 'Viral Lobbying. Strategies, Access and Influence During the COVID-19 Pandemic'
