Our young generation agenda was active at Dublin EPH, with a top notch <u>Young Researchers</u> <u>Forum</u> and several ASPHER Young Professionals, including YP Programme Coordinator and EB Member Ines Siepmann, in attendance. The YPs have closed applications for the 2024 intake – if you have <u>projects that could interest</u> them be sure to let us know! We also have <u>reflections from</u> <u>ASPHER Fellow Rok Hrzic</u> on the value of the ASPHER Fellowship programme and how he sees it can develop to contribute even more.

Most recently, ASPHER was happy to participate at the <u>Tallinn Charter 15th Anniversary Health</u> <u>Systems Conference</u>, where we were proud of and inspired by how schools of public health are contributing to trust and transformation for resilient and sustainable health systems. <u>President-elect Henrique Barros reflects</u> in detail on schools' social participation in this newsletter. While, ASPHER has also been busy following many other meetings over the autumn semester including <u>European Health Forum Gastein</u>, <u>ESCAIDE</u> and anniversary celebrations for the <u>European Observatory on Health Systems and Policies</u> and <u>EPHA</u>; as well as a series of professional development opportunities involving ASPHER members – <u>OMI Salzburg Seminars</u> and WHO trainings with a <u>Public Health Leadership Course at University of Bordeaux</u>, <u>Autumn School on Quality of Care and Patient Safety at NOVA National School of Public Health in Lisbon</u>, and the <u>Barcelona course on health financing for universal health coverage</u>. Planning for 2024, includes putting together the Public Health Training hub for our new website to make sure members can make the most of what is on offer.

Otherwise ASPHER's content agenda has been very, very busy. Especially the <u>Climate and</u> <u>Health Working Group</u> featured in this issue with attendance at <u>COP28</u> and an <u>ASPHER</u> <u>Statement calling for action on Climate and Health</u> issued on the COP28 Health Day, a high-level <u>EC conference on One Health</u>, and coordination for a free online <u>European Climate</u> <u>Change and Health course</u> in partnership with GCCHE scheduled to start in February 2024 – the course is open to all, so be sure to share widely with your network and students.

Meanwhile, the <u>Task Force on War and Public Health</u> has held a series of <u>meetings on the</u> <u>Israel-Hamas conflict</u>, including ASPHER members from the region. They have issued a <u>Task</u> <u>Force statement</u> that we hope will stimulate thoughtful discussion. Other <u>task forces and</u> working groups continue to meet regularly and the <u>Public Health Emergencies Task Force</u> has produced two new technical reports on the <u>Burden of Disease from Covid-19</u>; and on <u>Lessons</u> <u>Learned from Covid-19</u>. All ASPHER Members are welcome to join these groups. Contact us at <u>office@aspher.org</u> to register your interest, engage and be part of the ongoing exchange of dialogue, knowledge and activities.

After our focus on members, a key priority for ASPHER is the strengthening of partnership and synergy with other organisations and we are pleased to now be serving in committees with our key partner in the wider public health workforce professionalisation agenda, IANPHI. IANPHI, along with ASPHER, is also a member of APHEA and we are gratified to announce that <u>ASPHER</u> <u>President Carlo Signorelli has been elected as President of the Agency</u>. In his manifesto, he has pledged to align APHEA's missions and strategies with the Agency's members. Henrique Barros will also join the APHEA Board of Directors. We thank both John Middleton who served as APHEA President over the past term, and Mary Codd, who is stepping down from the Board of Directors; for their terms serving as ASPHER representatives.

We are pleased to be kicking off ASPHER participation in two new member-led <u>projects</u> this month: EU4Health project <u>VAX-Action</u> and Horizon project <u>EARLY</u>. Many other ASPHER members and partners help make up the project consortiums, strengthening contacts and collaborations. The Erasmus <u>SEEEPHI</u> project continues as well under difficult circumstances, but we are assessing how best to move forward. # EPH CONFERENCE REPORTING

Below you will find a listing of some of the ASPHER highlights during the Dublin European Public Health (EPH) Conference. We were on site as usual with the stand and it was great to catch up with many members onsite who were involved in presentations and sessions throughout the conference!

#### Young Researchers' Forum Dublin

As usual, the <u>ASPHER Young Researchers' Forum</u> was a high point during the EPH preconferences in Dublin. We always enjoy the event and are struck by the enthusiasm of some of the best and most motivated early career researchers in public health.

We congratulate all who participated in what was a very competitive edition of the YRF! And we offer special congratulations to the winners of best oral presentation and best poster presentation.



Best oral presentation for Dublin YRF was awarded to **Shevaun Teo of University College Dublin, IRELAND** for the presentation of her work on Investigation of Associations between Maternal Sociodemographic Factors with Placental Outcomes using Partial Least Squares Regression in the Lifeways Cross-Generation and PEARS Cohorts

Best poster presentation went to **Diana Juanita Mora Arias from Andalusian School of Public Health, SPAIN** for her poster of Effective Awareness Concerning Antimicrobial Resistance in Granada, Spain: A Field Study.

In addition to the organisation by ASPHER, the Dublin YRF was supported by EUPHA and the journal <u>Public Health Reviews</u>. As a prize from PHR and the Swiss School of PH (SSPH+), oral presentation winner Shevaun Teo has received an APC waiver to publish in the journal!

#### Plenary Session 3: Building the One Health Workforce

ASPHER co-organised Plenary 3 at this year's EPH Conference with the European Health Management Association (EHMA) bringing together representatives for the public health and health workforces to speak to 'Building the One Health Workforce'. ASPHER Executive Board Member and Core Curriculum Lead provided a keynote highlighting developments of the <u>ASPHER Core Curriculum</u> as relates to training for public health professionals in One Health; alongside a keynote form EHMA's Executive Director George Valiotis, on the <u>BeWell project</u> and One Health green and digital skills for health professionals.

#### Joint meeting of the ASPHER Task Forces on War and PH Emergencies

A special joint meeting of the ASPHER Task Forces on War and Public Health Emergencies was held as a closed meeting during the EPH Conference on the Israel-Hamas conflict. In addition to those attending onsite, ASPHER Member Colleagues from Israel and Palestine joined online. The meeting was gently led by ASPHER Task Force on War Lead Oliver Razum, but the focus was to give the floor to hear from local ASPHER members in the region and the colleagues they brought to the meeting. The meeting was difficult and intense, but the participants showed real courage to come together from all sides during such a troubled time.

In take away since the meeting, the ASPHER Task Force on War has taken on the arduous task of <u>drafting a statement on the conflict</u>. It is now available on the ASPHER website. We hope it will open further dialog. ASPHER continues to consult regularly with our affected members and is looking into sending a delegation to the region in January.

#### ASPHER Meetings during EPH

ASPHER took the opportunity of the EPH Conference to hold a series of in person meetings to advance on key aspects of the ASPHER Agenda. These included a meeting of the ASPHER Executive Board, the Climate and Health Working Group led at this meeting by member Chiara Caddedu, the Digital Public Health Working Group led by ASPHER Fellow Rok Hrzic, the Public Health Emergencies Task Force Vaccination Subgroup led by Alison McCallum and a special meeting to update and consult on developments of the Core Curriculum Programme with Lead Mary Codd and ASPHER Fellow Karl Conyard.



# ASPHER NEXT GENERATION PLATFORM UPDATES

#### The Next Chapter for ASPHER Fellowships

The ASPHER Fellowships are pivotal for mid-career public health professionals keen on contributing to innovation in public health training and instrumental for ASPHER in advancing its mission to enhance public health education and training across Europe. The synergy between the fellows' ambitions and ASPHER's goals creates a fertile ground for both individual professional growth and collective advancement in public health education. Take, for instance,

the achievements of Rana Orhan and Tara Chen, the climate-health fellows. Rana and Tara have been at the forefront of integrating climate and health considerations into public health training. They have contributed to developing <u>ASPHER's Climate and Health Competencies for</u> <u>Public Health Professionals in Europe</u> and led the initiation of the <u>Climate and Health Education</u> <u>in Europe Thematic Network</u>. Their example is a testament to the tangible change these fellowships can foster.

The next phase for the ASPHER Fellowships needs to focus on enhancing effectiveness and connectivity. The primary focus should be structuring the fellowships to better support the activities and professional development of the fellows. This includes fostering stronger ties between the fellows and ASPHER members and bolstering the Executive Board's oversight capabilities. Practical steps towards these goals could involve establishing a more transparent process for nominating and appointing fellows, organising regular fellows meetings to synchronise activities and develop leadership capacities, and designating a dedicated liaison to bridge the gap between the network of fellows, the Young Professionals Programme, and the Executive Board. I look forward to working with you all to transform these aspirations into tangible realities and further our pursuit of excellence in public health training and education across Europe.

# CLIMATE AND HEALTH

#### ASPHER at COP28



Thanks to the efforts of ASPHER Climate and Health Lead Laurent Chambaud, Climate and Health Fellow Tara Chen, and the Climate and Health Working Group, ASPHER was admitted to COP28 as an NGO with official observer status. ASPHER was represented onsite by Working Group member Balázs Ádám from Associate Member School United Arab Emirates University, who <u>shares his reflections from the event below</u>. Laurent, Tara and ASPHER President Carlo Signorelli attended COP online.

**For the first time at COP an entire day was dedicated to Climate and Health** which added to the importance of giving a voice to the concerns of Schools of Public Health onsite. ASPHER, through the Climate and Health Working group, issued a <u>statement for COP28 calling for action on Climate Change and Health</u>.

#### Reflections from COP28 by ASPHER delegate Balázs Ádám

The major climate action event of this year, the 28<sup>th</sup> Conference of Parties (COP28), was held in Dubai, United Arab Emirates (UAE). The country had high ambitions with hosting COP28 and provided excellent facilities on the previous grounds of Dubai Expo. With more than 80,000 delegates in the blue zone between 30 November and 12 December 2023, this COP received the highest ever number of attendees in COP's history, which signifies the extensive attention and expectations on immediate and efficient climate action, as it is becoming more and more




obvious that humankind is lagging behind with timely and effective solutions to combat climate change, which endangers the goal of the Paris Agreement to limit the temperature increase well below 2°C compared to pre-industrial levels.

In addition to the events organized by the United Nations (UN) in the blue zone, the UAE held several climate change-related activities in the publicly accessible green zone, where the number of registered green-pass holders exceeded 400,000. The figures clearly show the substantial interest in the issue of climate change not just from the related professional community but also from the general public.

I had the privilege to personally attend COP28 as a delegate of the Association of Schools of Public Health in the European Region (ASPHER). It was ASPHER's first time as an official observer NGO to COP, as well as my first time at such a high-level UN event, which filled me with excitement and interest. Both me and colleagues in ASPHER who followed COP28 online and supported my attendance (special thanks to Tara, Laurent, Lore and Robert) had to learn how to navigate in the rather complex and frequently confusing series of events.

One of the main issues on the agenda of COP28, which has never been so pronounced before, was definitely health. We had the first COP Health Day on the 3<sup>rd</sup> of December, replete with programmes about the various direct and indirect health effects that populations face as a consequence of climate change. It is clear that without immediate and extensive evidence-based action, these effects will grow more and more severe. Putting health officially on the table of climate-related political negotiations is a big achievement and I believe it increases the weight of arguments for quicker and stronger actions.

We, public health experts are convinced that in the health sector, public health is the field that understands and can do the most to tackle climate change, hence the participation of ASPHER on COP is a very timely and important mission. For the Health Day, <u>ASPHER prepared</u> and released its statement that calls for action on climate change and health in seven points that range from recognition of the linkages between climate change and health, through the need for training and capacity building to advocate on this important issue. The statement, together with







links to ASPHER's Climate Agenda, to a climate education survey and to information about the upcoming <u>European Climate & Health Course</u>, was distributed to several international and national climate and health organizations, such as the Global Climate and Health Alliance, the Global Consortium on Climate and Health Education, the WHO European Office, the Global Institute for Disease Elimination, and the Climate Change Research network of the UAE. Strengthening collaboration among organizations concerned about climate change and health will certainly improve their coordinated effort.

All in all, COP28 in Dubai was a great experience and good opportunity for ASPHER to have its voice heard and to expand its network so as to ensure its increasing contribution to climate action. Although COP28 has been extensively criticized due to the background of the chairperson as well as because the inevitable need for phasing out of fossil fuels was finally not included either in the Declaration on Climate and Health or in the Joint Statement on Climate, Nature and People, the establishment of a considerable fund for and bringing health in the forefront of climate action were undeniable achievements paving the road to the very needed international commitment to changing our societal and economic systems for the sake of a healthy future.

#### ASPHER Statement calling for action on Climate Change and Health

On Sunday the 3rd of December, on the occasion of the first ever COP Health Day, ASPHER issued a statement calling for urgent action on climate change and health in seven points.

For the first time at this COP28 on Sunday the 3rd of December, a full day was devoted to Climate Change and Health. The impact of climate change on health is an urgent and demanding public health emergency.



The 'ASPHER Statement for COP28: A call for action in seven points' outlines the perspectives of Schools of Public Health concerning the measures required on Climate Change and Health to limit the impact for human populations, ecosystems and the future of our planet.

Populations are already living with the effects and suffering the health consequences of global climate disruption. Continued procrastination will only exacerbate this planetary challenge.

The '<u>ASPHER Statement for COP28. A call for action in seven points</u>' has been published in the journal Public Health Reviews. <u>The pre-publication version is available here along with translations to several languages</u>. # Dark Forces are Acting on Climate Change Policies in Europe, and the World - blog by ASPHER past-President John Middleton

The world is burning and drowning. In this year of record temperatures of the air, the atmosphere and the sea, we are witnessing <u>extreme climatic events</u> from Acapulco to Libya, from northern China to East Africa. In Europe we have seen catastrophic forest fires and floods over the last three summers, affecting Greece, Portugal, Spain, and France. Climate records are <u>being continuously broken</u>.

Climate breakdown is happening before our eyes. More than 190 countries accept climate change as a real and existential threat and signed the <u>Paris Agreement</u> to reduce our reliance on fossil fuels collectively. We seem unable to take the necessary international action to tackle climate breakdown, by reducing our carbon footprints and stopping burning of fossil fuels. The situation is urgent. We are in a climate emergency. The only climate deniers at government level are now Russia and North Korea. So why is there so little evidence of shared concerted action towards an internationally recognised problem, and an internationally agreed treaty? Why and how has climate denial been allowed to reassert itself? And why is it still being given a platform? There are various actors, dark forces for climate denial, including political parties, industries, and think tanks, that are funded extensively by the fossil fuel industry. They are actively engaged in preventing action for reducing carbon emissions and are contributing to the likelihood of climate catastrophe. This paper describes some of the actions of these dark forces for climate disaster and examines strategies to address their influence.

ASPHER Task Force on War Lead, Oliver Razum firmly guided the process to reach consensus on the statement below. # Statement of the ASPHER Task Force on War and Public Health on the conflict in Israel/Palestine

The Association of Schools of Public Health in the European Region (ASPHER) reaffirms its condemnation of the terrorist attacks by Hamas that killed or abducted several hundred civilians in Israel on October 7<sup>th</sup>, 2023.<sup>[1]</sup> We call attention to the statement by the chief prosecutor of the International Criminal Court (ICC) who said that the atrocities committed by Hamas were "some of the most serious international crimes that shock the conscience of humanity", and that the ICC is ready to prosecute those responsible.<sup>[2]</sup> We also call attention to the Hamas Covenant of the Islamic Resistance Movement, originally issued on August 18, 1988,

that calls for the destruction of Israel, killing all Israelis, and calls for jihad on the Jewish people.<sup>[3]</sup> As public health professionals we condemn dehumanization and acts of genocide. We support Israel's right to armed self-defence within the limitations of international humanitarian law.<sup>[4]</sup> At the same time, we emphasise that Palestinians have legitimate aspirations to live with equal measures of security, freedom, justice, opportunity, and dignity.<sup>[5]</sup> This applies to all the people of the region and beyond.

We urge the immediate and unconditional release of all hostages held by Hamas. We particularly condemn all gender-based violence<sup>[6]</sup> and support UN calls for an investigation of the numerous accounts of sexual violence perpetrated by Hamas.<sup>[7]</sup> At the same time, we express our grave concerns about the millions of displaced people in Gaza and Israel as a consequence of the war. We call for all displaced persons to be enabled to return to their homes, with adequate support. We are concerned about the destruction of Gaza, in particular of hospitals and other civilian infrastructure, and the loss of life which has been inflicted on the people of Gaza, including women, children, and other non-combatants.<sup>[8]</sup> We are alarmed by the lack of water supply and sanitation, increasing the risk of communicable disease outbreaks. While we recognize the State of Israel and Palestinian jurisdictions, we assert that international bodies will need to sit in judgement on the conduct of Hamas and Israel as it relates to following international humanitarian law and the Geneva Convention.<sup>4</sup>

We believe the current humanitarian catastrophe is a testimony to years of neglect and abandonment of the people who should have been served by their governments. There has also been a failure on the part of the regional and global community. All could have done more to actively pursue peace and security for Israelis and Palestinians, fulfil their legitimate rights and aspirations, and enable harmonious development.

We believe there must be rapid, visible diplomatic efforts to create trust building practical steps towards peace and security for both sides. The conditions of ceasefire must be built upon, and massive humanitarian efforts must be allowed into Gaza, to enable urgent treatment for wounded civilians, and towards rehabilitation and recovery for the civilian population. There must be guarantees for the security of Israel who continues to suffer daily rockets and missile attacks. There must be moves towards a UN brokered multi-national peacekeeping effort in the region.

ASPHER is a public health organisation with more than 120 member schools including in Israel and Palestine. Our primary responsibility in war as in peace is saving lives. Public health leaders have moral and professional responsibilities to speak out about conflicts, and to contribute to prevention, limitation, and resolution of conflicts.<sup>[9],[10]</sup> Peace is more than the absence of war. Peace is an active process which requires all parties in conflict to desist from violence, and to seek peaceful solutions to their disagreements.

ASPHER is deeply committed through its members to assist all people and organisations affected by the conflict who are seeking to save lives and restore conditions for security and development. ASPHER greatly values colleagues in schools of public health in the region. We know that you have in the past sought to work harmoniously together in the interests of health and peace. ASPHER will make resources available to build bridges between Israelis and Palestinians. As health professionals we advocate diversity and respect.<sup>[11]</sup> We vigorously oppose antisemitism, anti-Muslim hatred, gender-based and sexual violence, and all other hate-based violence. As Schools of Public Health, we commit to developing the curriculum and

competencies for the role of public health in the prevention of violence, for response, rehabilitation, and recovery after conflict. We commit also to supporting our students and our staff by speaking up in the face of injustice and in protecting them from the harmful impacts of conflict and enabling them to play their roles in the public health response to violence.

# **Task Force on Public Health Emergencies**

# Technical Report: Examining the COVID-19 pandemic's unequal Burden of Disease

# How can Burden of Disease (BoD) measures that were used in the pandemic help in Examining European Health Inequalities (BoD-EEHI)?

This review was undertaken to identify which Burden of Disease (BoD) methods and metrics have been used in understanding the pandemic so far. Secondly, we wished to examine how BoD is usually measured and what are the strengths and weaknesses of the various metrics/methods. Thirdly, we also were interested in how BoD tools were applied during the COVID-19 pandemic and what initial studies told us for European populations and our vulnerable groups and how BoD evidence can inform us to help with assessing and reducing pandemic health inequalities and promoting equity. Finally, we also considered how BoD approaches might develop in future and what are ASPHER's priorities and recommendations to our members and to our partners, including further developing necessary teaching concepts and public health workforce competencies.

We recognised that five main tools were used to estimate population health losses, from early reliance on excess mortality measures, through life expectancy and Years of Life Lost (YLL) metrics, through to using YLD and DALYs as estimates of pandemic related disability.

Findings from the review shows that little explicit attention was drawn to health inequalities for deprived and minority population subgroups within most European countries, with some exceptions such as in Scotland. Better data systems will be needed in future pandemics to be able to assess these BoD inequalities more quickly.

The review discussed conceptual models and how future competencies could be developed in MPH courses and in public health training.

A series of 40 recommendations for future action are made. Delivering these actions would be a considerable challenge.

We are grateful to colleagues from the European Burden of Disease Network (Burden-EU) for presenting to us on their work. As health inequalities considerations may be implicit or have been overlooked in Burden of Disease studies of Europe's pandemic, it may be that a specific inequalities focus is needed in Europe - 'BoD EEHI' - Burden of Disease Examining Health Inequalities.

A joint statement between ASPHER and Burden-EU is in preparation to highlight the importance of continuing to further strengthen Burden of Disease systems before future pandemics and disasters.

# Technical Report: The COVID-19 Pandemic – Why we need to pursue the many public health lessons learned across European countries

#### Part 1. Sixteen priority lessons and recommendations for action during 2024-2026

Since 5th May 2023 Covid-19 is no longer considered a public health emergency of international concern (PHEIC), rather "an established and ongoing health issue".<sup>1</sup> But is now the time to forget about it, or the opportunity to learn the deep lessons for future pandemics and for shaping our teaching and our public health systems?

The WHO DG Tedros Adhanom Ghebreyesus, recognised the end of this emergency depicted a moment to celebrate some achievements, such as the dedication of healthcare workers but also a time for reflection on the many mistakes made.<sup>2</sup> Globally, as of 12th October 2023, there are 6,961,014 deaths due to Covid-19 and 771,191,203 confirmed cases reported to WHO.<sup>3</sup>

These large-scale numbers, even though they likely seriously underestimate the global burden, nevertheless signify a catastrophe for humanity and signal various global failures. Such failures include inadequate cooperation internationally, insufficient governmental examination of scientific evidence and hesitancy to adopt effective strategies, not ensuring equitable supplies and distribution of funding, technology and tools, and lack of concerned action to face disinformation and more.

Nevertheless, after acknowledging all the mistakes, it is time to learn from the past and act to take advantage of the window of opportunity that is still open before the next large-scale global health emergency. Our 16 key lessons learned and our recommendations draw from three broad sets of influences below, all of which overlap but none of which are sufficient on their own.

- 1. Findings from seven important international reports from other agencies (Chapter 2).
- 2. Perspectives of ASPHER PHE Task Force members and subgroups who were part of a large number of ASPHER meetings and reviews during the pandemic (Chapter 3).
- 3. Country experiences and perspectives from ASPHER PHE Task Force members (see Lesson Learned report Part 2 to follow).

### **Digital Public Health Working Group**

ASPHER established a working group focused on examining the impact of digital transformations on public health education and training. Since its inaugural meeting in March 2023, this working group has been led by Rok Hrzic (<u>r.hrzic@maastrichtuniversity.nl</u>), Assistant Professor at Maastricht University and an ASPHER Associate Fellow in digital public health.

An early achievement of the group includes developing a set of principles for revising public health curricula considering digital transformations, showcased at the Deans' and Directors' Retreat in Dublin in September.

Underpinning the working group's efforts is a four-pillar strategy encompassing reviewing public health curricula, identifying training needs arising from digital shifts, monitoring existing educational offerings, and reviewing digital skills certifications.

Recently, the working group further expanded its scope by launching a subgroup dedicated to understanding the impact of social media on public health.

As we continue our work in 2024, we invite collaboration with ASPHER members, hoping our collective efforts will prepare public health education and training in Europe for the opportunities and challenges of the digital era.

#### Public Health Undergraduate Education Working Group

The Public Health Undergraduate Education Working Group meets on a regular basis under the leadership of Kai Michelsen, Fulda University of Applied Sciences.

The working group is currently working to put together a comprehensive listing of undergraduate offers at ASPHER member schools. They are also considering how undergraduate education in public health can contribute to lifelong learning.

# Tallinn Charter 15th Anniversary Health Systems Conference: Trust and transformation – resilient and sustainable health systems for the future

On 12–13 December 2023 WHO Europe and the Ministry of Social Affairs of Estonia and the European Observatory on Health Systems and Policies hosted a <u>high-level health systems</u> <u>conference titled "Trust and transformation: resilient and sustainable health systems for the future"</u> to commemorate 15 years of the Tallinn Charter: Health Systems for Health and Wealth.



The Observatory generated evidence to inform each of the Tallinn meetings: evidence on the dynamic relationship between health systems and economic development; on the benefits of health systems strengthening and all-ofgovernment and all-of-society approaches; and on how to include, invest and innovate. For the 2023 conference, it has produced a suite of five policy briefs in support of the key themes of trust and transformation collecting key messages together. The briefs themselves are available for consultation and will be revised and published in light of the conference discussions.

ASPHER President-elect and Director, Henrique Barros and Robert Otok were pleased to attend and take inspiration from how schools of public health contribute to the agenda on resilient and sustainable health systems for the future. **Following here**, <u>Henrique provides his reflections</u> <u>from the event</u>. The Tallinn Conference also allowed for reflection over the ongoing discussion on public health and primary care, which was then focus of another high level conference on <u>Implementing</u> <u>Policy and Practice for Primary Care - Celebrating the 45th anniversary of Alma-Ata and 5th</u> <u>anniversary of Astana declarations</u> and subsequent Observatory webinar on <u>Integrating public</u> <u>health and primary health services: building strong foundations for population health</u>.

Extra reading of a freshly released <u>European Commission synthesis report</u> on country health profiles will help inform relevant discussions going forward.

## The Schools of Public Health and Social Participation in Health Systems Functioning – conference notes by ASPHER President Henrique Barros

Health challenges are ever changing and societies are evolving accordingly. Individuals increasingly ask for more intelligent, more comprehensive and timelier decisions regarding the way health systems are structured, funding is decided and human resources are trained.

Emerging issues related to the delivery of care as access to innovation may finally, on a daily basis, be more relevant than the concerns with emerging health threats. They are perceived as major turning points in the process of evaluation of health systems, through the eyes of users. The perception of the functioning of health services, and the extent of citizens involvement in the whole process, influences trust and consequently needed transformation. Every movement can be seen as a missed or gained opportunity to global improvement and to a more person-centred, human-rights respectful way of dealing with citizen/patient – health professional encounters.

To a certain extent all this is mainly a question of health literacy. It has to do with the way health education and communication is handled in societies and how behavioural insights are perceived.

Thus, if we take this perspective, the central role of training the health professionals, in particular the public health workforce, becomes clear. And we underline the public health professionals because they are pivotal in promoting health, designing and implementing preventive programmes and organising the management of the different levels of care. And by doing it, public health has a most relevant role in defending the health care systems, as it leads to avoid preventable situations while making the always limited resources available to face the more severe and demanding situations.

Schools of Public Health, especially those organised as ASPHER members, play a fundamental role in responding to the need of well trained and educated professionals. Training the workforce, valuing skills and competences in health education and communication, influences directly and indirectly the health literacy capital of the communities and empowers individuals to make more rational choices. Particularly if children and youth are targeted so that sustainable life course gains are expected.

ASPHER has been engaged in developing competency goals for public health professional training standards, in accrediting schools and programmes through the work of APHEA, in building a professionalisation roadmap, in close collaboration with WHO Europe, it is now

defining an ambitious core curriculum programme, and looks at the organisation of life long education schemes.

Decades of work, we believe, contributed to technically prepare a strong public health European community able to respond to increasingly complex challenges. But it is time to recognize that new skills and new approaches are needed so that co-creation can be seen as a desirable and the public is actively present in public health decisions and evaluations – as true subjects and not mere objects of top-down actions. ASPHER is committed to lead such process involving professionals and citizens in the organised community effort that defines public health, and valuing both the knowledge and commitment of people in a truly solidary, shared global world.

#### VAX-ACTION: Tackling Effectively Vaccine Hesitancy in Europe

VAX-ACTION, which is co-funded by EU4Health, aims to support EU Member States and relevant stakeholders to implement a combination of tailored, evidence-based interventions aimed to reduce vaccine hesitancy. It addresses the need to understand what type of interventions are now available, which are effective, how to translate effective interventions to new contexts, and to explain the unsuccessful ones to create opportunities for learning and redesign.

VAX-ACTION is coordinated by IHMT, NOVA University Lisbon, PORTUGAL under the lead of Prof Tiago Correia and builds on previous EU projects in the area. It brings together a consortium of ASPHER member schools, including University Vita-Salute San Raffaele, Milan, ITALY; EHESP School of Public Health, FRANCE; National School of Public Health, Management and Professional Development, ROMANIA; Catholic University of the Sacred Heart, Rome, ITALY; Institute of Public Health, University of Porto (ISPUP), PORTUGAL; Institute for Postgraduate Medical Education (IPVZ), CZECHIA; and University of Pavia, ITALY. ASPHER is responsible for the work package on dissemination.



The project held its kick off meeting on the official project start date on 1st of December and will regroup in early January to sign off on our partnership agreement. We'll keep you posted on developments.

### EARLY: Evaluating, Identifying & Reducing determinants MHC in Youth

The EARLY project aims to reduce the burden of non-communicable diseases such as mental health conditions (MHC), especially depression, anxiety, stress disorders, substance use disorders and identify and reduce risky modifiable exposures for these conditions in youth. EARLY will pursue this goal through developing a comprehensive exposure matrix which can be adapted to emerging new risks, to understand youth, parents`, and stakeholders' perceptions, we will conduct qualitative, interviews, by providing representative, multinational data on youth MHC and through developing, implementing and evaluating a multicomponent intervention. This will serve as an innovative model for promoting mental health and preventing MHC.

EARLY, which is co-funded through Horizon, is coordinated by the Technical University of Applied Sciences in Emden/Leer, GERMANY with Prof Jutta Lindert leading. Other ASPHER members involved in the consortium include Tirana Medical University, ALBANIA; University of Bremen, GERMANY; Medical University of Gdánsk, POLAND; University of Porto, PORTUGAL; and University of Novi Sad, SERBIA. ASPHER will be tasked with development of mental health training activities tailored for youth and carers.



The project, which started on 1st of December, held an introductory meeting of partners on 13 December. The kick off meeting is planned for 11-12 January in Emden, Germany.

#### SEEEPHI: Sharing European Educational Experience in PH for Israel

Unfortunately, the SEEEPHI project is facing disruptions due to the conflict in Israel since 07 October. All Universities remain closed, medical personnel are unable to travel, and many partner leads are involved in both required and voluntary duties related to support efforts. We were finally able to gather partners together for a Zoom call on 19 December to assess the situation and take stock of where things stand with the project.

As a result we are seeking a project extension in order to complete all activities. ASPHER is also working on plans to send a delegation to Israel and Palestine under the SEEPHI project umbrella – working on how public health training applies under conflict.
