As well as acceptance of eight new Member Programmes and one new Associate Member, representing a diverse set of Schools from across the European Region and beyond.

We will have one piece of continuity this year. We are thrilled that our terrific Intern, Naomi Lamora Nathan will continue to work with us as an ASPHER Fellow. Naomi has been an exceptional Intern and presence at ASPHER and you can read more about her internship experiences here in the newsletter and in her blog post at aspher.org.

There are many other interesting activities and opportunities highlighted in the newsletter and we hope you take advantage to get involved and participate. # 2019 ASPHER DEANS' AND DIRECTORS' RETREAT Report from Erice






### Handover of the ASPHER Presidency



At the General Assembly, Prof. Kasia Czabanowska handed the ASPHER presidency to Prof. John Middleton presenting a <u>report</u> of her two-year presidency.

Prof. Czabanowska's presidency was devoted to public health workforce development and was very much appreciated by ASPHER Members. She was engaged in many activities and direction setting projects such as the Road Map for Professionalising Public Health and WHO EURO-ASPHER European Competencies Framework for Public Health

Workforce, ASPHER Public Health Training Academy (PHTA) Hub and also This is Public Health (TIPH) Europe campaign together with the North American Association of Schools and Programs of Public Health (ASPPH) to support and leverage the recognition of the public health field and stimulate greater interest in choosing a career in public health.

Prof. Czabanowska is grateful to have been given the opportunity, trust and support of ASPHER members and collaborating organisations.

Prof. John Middleton assumed his position with a stirring Presidential Statement during the Opening Session in Erice. See the "Message from the President" about and the full text of his statement in his <u>blog post</u> on the ASPHER website.

Prof. Middleton expects to be blogging at ASPHER on a regular basis, so keep tuned to the website. Meanwhile, Prof. Czabanowska will still be closely involved with ASPHER as Immediate Past President. Prof. Middleton invited Prof. Czabanowska to continue to lead on the professionalization agenda making it a horizontal, cross-cutting theme of ASPHER activities.

## Andrija Štampar Medalist announced

Gaetano M. Fara, MD, MPH, PhD was announced as the 2019 ASPHER Andrija Štampar Medalist for excellence in the field of public health. Since graduating MD cum laude in 1958, Professor Fara has gone on to receive MPH and PhDs in both Hygiene and Microbiology. He has served as a Member of the Faculty in several institutions and served as Director of the Institute of Hygiene in Milan and Rome, of the Department of Public Health Sciences in Rome and of the University Hospital Centralized Laboratory in Milan as well as Chief of the Hospital Hygiene Service in Rome.

Professor Fara's chief scientific interests are in epidemiology of infectious diseases, in environmental health, in the evaluation of vaccinations and in health organization and management. He spent time in the UK and USA working in epidemiology of viral diseases and vaccination policies. He has worked on Vaccination issues at the governmental level in Italy and with WHO Europe. At the time of the Seveso Chemical Disaster (1976) he was appointed President of the Epidemiological Committee in charge for the event and, later, Secretary to the International Seveso Steering Committee.

Currently, Gaetano M. Fara is Professor Emeritus of Public Health at Sapienza University of Rome, Department of Public Health and Infectious Diseases. He is Editor in Chief of Annali di Igiene and Director of the International School of Epidemiology and Preventive



Medicine at the Ettore Majorana Foundation and Centre for Scientific Culture in Erice.

In addition to hosting the Deans' and Directors' Retreat at the Ettore Majorana Foundation, Professor Fara gave a Keynote Address on "The Contribution of Italian Schools to the Progress of Public Health in the European Region" during the Opening Ceremony.

### ASPHER Deans' & Directors' Good Practice Award



The 2019 ASPHER Deans' & Directors' Good Practice Award for excellence in public health training and education went to the European Centre for Disease Prevention and Control (ECDC) Fellowship Programme: EPIET & EUPHEM. The ECDC Fellowship Programme is a two-year competency-based training with two paths: the field epidemiology path (EPIET) and the public health microbiology path (EUPHEM).

After the two-year training, EPIET and EUPHEM graduates are considered experts in applying epidemiological or microbiological methods to provide evidence to guide public health interventions for communicable disease prevention and control.

Both curriculum paths provide training and practical experience using the 'learning by doing' approach in acknowledged training sites across European Union (EU) and European Economic Area (EEA) Member States.

The programme aims to strengthen the surveillance and control of infectious diseases and cross-border health threats; to engnance response capacity for effective field investigation and communicable disease control; to strengthen the European network of public health professionals; to support training and capacity building in Member States; and to facilitate multi-disciplinary cooperation.

Professor Karl Ekhdal was present in Erice to accept the award.

### ASPHER Executive Board: New Members

In addition to welcoming, its new President, the ASPHER General Assembly voted in two new Members to the ASPHER Executive Board:



Mary Codd (MD, MPH, PhD, FFPHMI), Associate Professor of Epidemiology & Biostatistics at the School of Public Health, Physiotherapy & Sports Science (SPHPSS) at University College Dublin (UCD), Ireland. She has been an active member of ASPHER for the past 10 years. She is a member of the ASPHER Working Group on Doctoral Programmes and Research Capacities (report, May 2013), is hugely supportive of the ASPHER Young Researcher Forum and an advisor on the 5th Edition of ASPHER's Core Competences for the Public Health Professional. She has also served as an external examiner with APHEA. As a member of the Executive Board, she will be fully committed to supporting and advancing the mission of ASPHER

with, and on behalf of, current and future members of the organisation.



Oliver Razum (Prof., Dr. med., MSc), Dean of the School of Public Health, Bielefeld University, Germany. His work is in social epidemiology with a focus on refugee/migrant health, as well as on Global Health. Oliver has been representing Bielefeld School of Public Health at ASPHER since 2006. He has been actively engaged in ASPHER's work on refugee health As an ASPHER Executive Board member, Oliver plans to continue his engagement for the health needs of migrants, and in particular of refugees. Key concerns are safe passage and access to health care during transit; EU immigration laws; entitlement and access to health care; tackling root causes; and education and training in refugee health.

Laurent Chambaud (Treasurer) and Dejana Vukovic stepped down from the Executive Board. We warmly thank them both for their years of service to ASPHER! Henrique Barros has assumed the role of Treasurer.

## Working Group and Project Reports

### Report from the ASPHER Honours Committee

The 2019 ASPHER's Honours Committee Meeting took place during the ASPHER's Deans' and Directors' Retreat in Erice, Italy, with Vesna Bjegovic, Roza Adany, Jeffrey Levett, Ted Tulchinsky, Franco Cavallo, Anders Foldspang, Martin McKee, Jacek Sitko, Kasia Czabanowska, Jacqueline Müller-Nordhorn and Jose Martin-Moreno participating.

The HC re-elected Jose Martin-Moreno as the Co-Chair for the next two years, in conjunction with Kasia Czabanowska (as the immediate Past President of ASPHER). Special thanks were expressed to the outgoing Co-Chair, Jacqueline Müller-Nordhorn.

The HC expressed a desire to be more than just the committee of the village elders, offering itself as ambassadors or to assist in ASPHER's work when required, and productively mentoring new Public Health leaders. In that sense, the HC believes that Young professionals can be a great asset in support of Public Health and... Senior professionals can be a great asset in support of Young professionals...

For all these reasons, the HC promotes and supports the ASPHER ASSETS initiative: The Andrija Stampar Summer Educational and Tutoring School, which will take place in Brussels in the week that starts on 15 July 2019, and which we hope will be the beginning of an initiative that will have a huge impact on Public Health education.

## **European Public Health Reference Framework:**ASPHER's European List of Core Competences for the Public Health Professional

Initiated in 2006 and endorsed by WHO's European member states in 2012 (see <a href="WHO's European Action Plan for Strengthening Public Health Capacities and Services">WHO's European Action Plan for Strengthening Public Health Capacities and Services</a>, p. 18), the 5th edition of ASPHER's List of Core Competences for the Public Health Professional was published in June and November 2018 as an ASPHER Publication and as a supplement to the Scandinavian Journal of Public Health, respectively. You will be able to find the SJPH supplement at the internet address <a href="http://journal.sagepub.com/home/sjp">http://journal.sagepub.com/home/sjp</a> - and the whole history as well as previous editions of the list are available at ASPHER's homepage.

At its meeting on the 27th May, during the Deans' & Directors' Retreat in Erice, the Council of ASPHER's European Public Health Framework (EPHRF) agreed to make a proposal to the ASPHER Executive Board to initiate production of the 6th edition to the ASPHER Executive Board, so that it can be published by the end of 2020. Repeated scrutiny is a prerequisite in the short- and long-term continuous development and quality control philosophy of the list. Thus, the 5th edition (2018) was developed from the 4th edition (2016) based on scrutiny by and advice concerning adjustment from external experts within methodology: epidemiology and biostatistics; population health: sociology, environmental health; interventional systems and processes: health economics; leadership and systems thinking; nutrition; communicable disease control.

As concerns the development of the 6th edition, the intention is to ask for advice concerning adjustment from external experts within health promotion, public health law, public health ethics. Moreover, an overall scrutiny from the point of view of academic education in political science is also intended, and public health nutrition shall be reviewed again, the many developments in the field considered.

There have been suggestions to translate the list into other languages than English. ASPHER's administration will take care to ensure the quality of the legal background for such positive development.

## Kick-off of the new ASPHER Working Group on Economic Evaluation in Healthcare in Europe (EEHE)

The ASPHER Working Group on Economic Evaluation in Healthcare in Europe (EEHE), which was established in Erice, had its kick-off meeting on 2nd of July, 2019. Representatives of 12 European countries joined to discuss the workplan and outline the group roadmap. The group will be coordinated by Maastricht University.

The ultimate goal is to establish the current status, future needs and good practices in teaching healthcare economic evaluation in Europe. The focus will be on both course content and educational approaches, also, encompassing exchange of best practices and know-how.

The work will start by charting the current system of teaching economic evaluation, and assessing the gaps. The ambition is to develop new teaching standards and a model curriculum.

It is expected that the participation in this working group will enable institutional ASPHER members in Europe to review, renovate and expand their teaching and training material in the area of healthcare economic evaluation.

### Public Health Law Working Group: Putting Legal Epidemiology into Practice

Legal epidemiology is an emerging discipline. It aims at the scientific study of the relation of law and legal practices to population health. It is built on evidences that the law is one of the most effective social determinant of health.

The focus of the May 2019 ASPHER Deans' and Directors' retreat in Erice, Sicily was on the development and training of public health workforce. A full session was dedicated to legal epidemiology and to the sharing of experiences of legislation being used as a public health intervention instrument. Evidence-based examples were provided to highlight how

national laws contribute to decreasing health-related risks (vaccination, tobacco control...), promoting access to healthcare in conformity with human rights and strengthening countries' IHR(2005) core capacities to prevent, prepare, control and respond to the spread of diseases across countries. The role of social scientists, including but not limited to economists, lawyers, political scientists, in the process of translating evidences in sound public health policies was highlighted and recommendations were made that they be fully recognized as part of the public health workforce.

The public health law working group also recommended to further integrate social sciences to the core public health workforce curricula. In this regard, minimal core legal capacities should be delineated and corresponding courses integrated to core public health workforce training programs. Their purpose would be to ensure that all core public health workforce professional understands legal epidemiology to ensure a leadership role in better using the law in public health.

A transdisciplinary model, where public health and social sciences experts work together to promote health, requires common understanding, methodological tools such as the emerging field of legal epidemiology and common trainings. In this respect, the three-day course "Better health faster: Using Law and Policy Effectively in Public Health", during the SSPH+ Lugano Public Health School, August 29–31, 2019 offers an opportunity for all these professionals to learn to work together.

Beyond the Erice retreat, Prof. Dominique Sprumont also participated in July 2019 at a meeting at WHO headquarters in Geneva on the legislative needs of the countries in implementing the IHR(2005). Using the legal epidemiology approach was recognized as essential to achieve the broader objective of universal health coverage. ASPHER could play an important role in this process both in providing training and contributing to the research and public health interventions in the field.

#### **Undergraduate Programmes in Public Health Working Group**

A meeting was held which focused on the status of undergraduate programmes among ASPHER member schools (and beyond). There was much interest in surveying ASPHER member schools and non-ASPHER members to identify the existing programmes for undergraduate students. This updated survey would build upon the ASPHER survey conducted in 2010. Globalizing the curriculum is recognized as a high priority and a current inventory of resources can lead to collaborations between programs to further promote options for undergraduates for public health careers.

Erasmus funding could be sought as well for future collaborations. The importance of English language programmes was stressed for maximal access to scholarly materials and resources.

### The ASPHER V4 Working Group strongly supports WHO CoP

Knowledge transfer and information sharing is an integral part of public health capacity development. Successful international cooperation, in particular cooperation of neighbouring countries, is an important approach. The working group of V4 (Visegrad) countries, established in 2016 as one of the working groups of The Association of Schools of Public Health in the European Region (ASPHER), is focused on public health capacity development in V4 countries. Strong V4 cooperation is needed to cover current European public health problems and to strengthen awareness of the importance of public health leadership in the European context.

The ASPHER V4 Working Group (WG), co-chaired by Dr. Alena Petrakova, Faculty of Medicine and Dentistry, Palacký University in Olomouc, Czech Republic, and Robert Otok, ASPHER Director, supports the Coalition of Partners (CoP), established by the WHO Regional Office for Europe to develop and implement a joint Agenda for Action focusing on the enabling functions of public health services.

The ASPHER V4 WG is in particular involved in testing of the recently developed Rapid assessment tool, which is important for final preparation and implementation of a Road Map for further professionalization of the public health workforce in the WHO European Region. This topic was discussed in details by the representatives of public health experts from all four V4 countries at the 4<sup>th</sup> V4 Public Health Conference, held in April 2019 in Debrecen, Hungary. Further work on this task continues in all V4 countries and its results will be discussed by the ASPHER V4 WG at the upcoming public health international meetings and next steps will be discussed at the WG meeting in November 2019 at the 12<sup>th</sup> European Public Health Conference in Marseille, France.

## ASPHER 2020 - Advancing and Evaluating the Agenda

ASPHER is beginning the process to evaluate the <u>ASPHER 2020 Strategic Agenda</u> this summer, while taking the opportunity to further advance the Agenda through 2020. The 5 strategic objectives for 2016–2020, include:

Strategic objective 1: Improving quality of academic programmes and CPD for public health;

Strategic objective 2: Strengthening research capacity among all members;

Strategic objective 3: Setting up a public health profession for public health services in Europe;

## War is a "man-made public health problem": ASPHER stands with the Turkish Medical Association

ASPHER has issued the following statement in solidarity with members of the <u>Turkish Medical Association</u> who have been convicted of "inciting hatred and hostility" and sentenced to prison in Turkey. For a pdf version of the statement please follow the link here.

### ASPHER considers war as a "man-made public health problem".

Wars and armed conflicts have devastating consequences for the physical and mental health of all people involved, for the social life within and surrounding the war-affected regions, and for the health of the environment. Wars destroy health infrastructure, undoing years of health advancement, and severely compromise health systems' capacity to respond to the direct and indirect health consequences of fighting. Millions of people have been internally displaced or forced to flee their countries due to armed conflict. Forced migration creates further physical and mental health problems during transit, in enforced encampment, and due to restricted entitlement to health care in countries hosting refugees. The disastrous effects may last for generations to come. In short, war is a man-made public health problem.

In January 2018, following the Turkish government's announcement of a military operation in Afrin, Syria, The Turkish Medical Association (TMA) issued a public statement, declaring that "war is a man-made public health problem". Eleven present and former members of the TMA's central council were subsequently arrested and released after one week in custody. They were then put on trial, and on 3 May 2019, they were sentenced to 20 months in prison with the charge of "inciting hatred and hostility." One member was further charged with "terrorist propaganda", with an additional 19 months in prison for their social media activity.



ASPHER recognizes the unequivocal evidence that war is a man-made public health problem. ASPHER is committed to direct the attention of the public and of policymakers to the irrevocable damage armed conflicts inflict on population health. Consequently, ASPHER stands in solidarity with the convicted TMA members.

### TRAIN4M&H Stakeholder Dissemination Workshop



Following the MIG-H event in Ljubljana, ASPHER is continuing its participation in migration health training actions with the EU funded TRAIN4M&H. The Stakeholder Dissemination Workshop for the project

was held in Brussels on 25 June, bringing together participants from 27 countries from across the European Region representing diverse professions and institutions including the European Commission, National Ministries, Police Commissions, Schools of Public Health, NGOs and others. ASPHER participated with President John Middleton taking part in an Expert Panel and moderating the question and answer session. Robert Otok served as an Expert Advisor to the Panel Discussions.

As part of its role in the action, ASPHER will host a web platform with training material developed as a result of both projects. It will be set up as a dynamic online environment and reference point for up-to-date training resources on migration and health. The online platform will serve to disseminate MIG-H/TRAIN4M&H among all ASPHER members, but will also allow you and other contributors to upload and share your relevant content based on international, country and local experience and actions. The platform, which has been developed by the French School of Public Health (EHESP) is still in the testing phase and awaiting approval by the European Commission. We will be sure to let you know when it is available!

We expect that the platform will contribute to the development of the Public Health Training Academy/Hub as a Europe-wide continuing professional development scheme for the public health workforce. ASPHER plans to utilise it as a model for training content related to other projects, such as Human Rights in Patient Care (HRPC) and the InfAct Joint Action.

## World Federation of Public Health Associations General Assembly

Naomi had the opportunity to present the ASPHER Governance structure at the WFPHA Transformational Leadership Workshop, sharing the best practices of ASPHER to the members of the WFPHA.

## 72<sup>nd</sup> World Health Assembly

WHO's 72<sup>nd</sup> World Health Assembly (WHA) was held from 20-28 May in Geneva at the Palais des Nations. ASPHER Intern, Naomi Nathan attended as part of the Medicus Mundi International (MMI) (Non-state actors) delegation via the Maastricht Center of Global Health.

Naomi reflected on the event in a podcast <u>episode</u> of "<u>Talk Public Health</u>" with her colleague, Nikita Charles Hamilton, intern with the IANPHI Secretariat at Santé Publique France.

Naomi reports that the experience provided her with insight into global public health issues, particularly health workforce, health financing and governance which are her areas of interest in public health.

Two highlight points for improvement, from her reflection on the event were:

The continuous emphasis on the dire need to involve "young people" in public health processes as the future workforce. However, she was dismayed by the low representation of young public health professionals at the WHA and lacks clarity on **how** "young professionals" will be involved and enabled to contribute to these issues. In her opinion, young public health professionals need to be given an opportunity to be present at events like the WHA as it clearly provides insights to the reality of their career path.

Secondly, she noted a lack of clear communication and knowledge translation in public health. She saw how public health professionals tend to remain in their bubbles, **not knowing how to effectively translate and communicate messages to other sectors/lay people**. As a young public health professional, she would like to point out that it is necessary for clear communication and knowledge translation skills to be highlighted in students' educational and practical experiences in order for them to collaborate across sectors and effect change as they enter their careers.
