- 2.6.1. YPP/ASSETS meeting in Brussels Ines Siepmann reported:

Meeting was successful with 6-10 participants onsite each day. Discussion was held over strategic building and sustainability of the YPP programme. IS thanked RO for his work on the event

Over 60 applicants were received for the 2022 YPP intake and are currently being reviewed.

IS informed that she had accepted and employment offer with the CDC in the United States, but she would continue with her post on the ASPHER EB.

- 2.6.2. Professionalisation of the Public Health Workforce Task Force (PPHW-TF) launch Robert Otok reported on the launch of the PPHW-TF and informed that there would be further meetings with Kasia Czabanowska next week.

RO reported that the project kicked off last week with major ERASMUS+/EU funded agenda on skills for health

EHMA leads with EuroHealthNet providing public health perspective **Action:** ASPHER will track project developments to ensure synergy with the PHW professionalisation agenda, and the ERASMUS effort led by Polychronis. Other items discussed to consider for PK ERASMUS proposal:

- Consider delaying application to next year for better timing to synergize with ASPHER core competencies/curriculum work and outcomes of first year of BeWell (or still try to submit this year in order to have feedback from reviewers)
- Coordinate with UCCAIDE implementation in practice
- Consider Jim Campbell and GNAPH work
- Application must go beyond ASPHER membership and include employment side alliances
- BeWell mapping from project year 1 could provide input to a project proposal next year

Action: Schedule urgent meeting with PK (including MC) to keep options open. The EB indicated that they were invested in taking the ERASMUS proposal forward.

2.7.2. Global Alliance on War, Conflict and Health (GAWCH):

Oliver Razum reported that the GAWCH had launched on 1 July with approximately 100 members, led by ASPHER TFW member Samer Jabbour.

3. New Member Application

RCSI University of Medicine and Health Sciences, Dublin, IRELAND (see <u>https://www.aspher.org/download/1176/rcsi_aspher-ma2022.pdf</u>) The EB questioned whether RCSI was relevant for membership in ASPHER given that it was focused on medicine rather than public health.

RO indicated that the criteria has been relaxed in the past, but that there should be some training element.

MC added what she knows about RCSI - as a private college aligned with the North of Ireland. She welcomed their interest as an indication that ASPHER is becoming better known as an international network.

LL informed that based on email communications with the RCSI contact, they had indicated that they were planning to launch a School of Population Health in Autumn 2022. The EB unanimously approved provisional ASPHER Membership for RCSI University of Medicine and Health Sciences

4. EPH Conference - Berlin 2022: ASPHER/EHMA joint plenary outline

(see: <u>https://www.aspher.org/download/1179/eph-plenary-aspher-ehma.pdf</u>) Robert Otok informed that he had met yesterday with EHMA to discuss the proposed joint ASPHER/EHMA Plenary 5 scenario.

Two keynotes will be made from WHO-Europe on the Professionalisation Roadmap and from EHMA on BeWell.

Speakers in the panel will include representatives from UK PHR to speak to the global agenda and WHO roadmap, EHMA BeWell project coordinator, and EHESP on One Health approach.

Plenary 5 will be held on the final conference day (Saturday morning).

5. WCPH - Rome 2023 (https://wcph.org/)

Carlo Signorelli informed about progress for the WCPH-Rome which will take place from 2-6 May 2023. The event title will be: World in Turmoil ASPHER has been given several session spaces, but it is still early to decide how to use them – it will be discussed further after the Deans' & Directors' Retreat. Mary Codd asked about World Leadership Dialogs costs, which require payment to participate. CS indicated that these were generally sponsorship arrangements or sometimes charitable foundations to promote projects and activities. They would be out of ASPHER's budget.

Actions: Keep WCPH on the agenda for promotion and discussion at Sofia and Berlin EPH. CS to send official promotional materials to use on ASPHER and member websites

6. Deans' & Directors' Retreat - Sofia 2022: programme outline
