## HIGHLIGHTS OF THE ASPHER YEAR

There are two kinds of public health - the health of the public, and the public health profession, service and system. The health of the public is everybody's business - it requires multidisciplinary and multi-agency action from all corners of society and it requires trust and cooperation with the public themselves. It is 'everybody's business', but nobody does it, without the efforts of public health professionals, public health services and a public health system. We are the conductors of the orchestra, or the grit in the oyster, or the catalyst for action... 2022 has been a terrible year for the health of the public. The COVID-19 pandemic has claimed nearly 7 million lives so far with many more unaccounted and perhaps 20 million as a central estimate of excess deaths. The Russian aggression against the Ukraine has caused immense suffering in Ukraine, massive displacement of refugees and global problems of energy shortage, inflation and food shortages, threatening mass starvation in parts of the world like the Horn of Africa and the Middle East. European countries been hit by spiralling inflation, energy shortages, social care challenges for their residents and refugee populations, health care systems are under intense pressure in many parts of the continent, and climate breakdown has been witnessed in the form of wildfires which have burned the equivalent of three Luxembourgs worth of land mass. As public health educators all we can do is train our people to be effective operators against the massed array of health threats. It is all anyone can do to ensure the best possible actions to produce and improve the public health professionals who will serve us in the coming years. ASPHER colleagues have continued to undertake great and selfless work over 2022, professionally, calmly, unnoticed, and uncelebrated, going about the business of training and education. So we present here some highlights of how ASPHER has sought to help its members, advance the quality and quantity of excellent training, with the aim of improving and protecting the health of people and planet.

#### 1. ASPHER European and Global professionalization and workforce capacity development





In February ASPHER joined with WHO Europe to launch the Road Map for Professionalization. We particularly thank Kasia Czabanovska and Natasha Azzopardi-Muscat WHO EURO, for their efforts in bringing this to fruition. Our professionalization task force is beginning to set out a strategic agenda we hope European countries and schools of public health will join in and develop strongly.

#### 2. ASPHER competency development

In February, ECDC published the Core Competencies in Applied Infectious Disease Epidemiology in Europe. This was commissioned from ASPHER and was a two-year labour of love by Mary Codd from University College Dublin, with the support of ASPHER colleagues and an extraordinary effort from our Secretariat. The competencies are strongly recommended not just for European schools but more widely.

The wider review of our core curriculum guidelines was launched at the Sofia Dean's Retreat in October. Please <u>contact Mary</u> if you have ideas about this work. We intend to launch the revised curriculum in Dublin at the 2023 Dean's Retreat.

#### 3. ASPHER young professionals

#### 4. ASPHER COVID task force



The <u>ASPHER COVID-19 task force</u> has continued to meet weekly. It passed its 100<sup>th</sup> meeting in 2022. In March we thanked <u>ASPHER members for their commitment during the pandemic</u>. Nadav Davidovitch took over from John Middleton, as chair of the task force in February and has served us with distinction.

Nadav and Rok successfully led a European Public Health session on the working of the task force in November.

#### 5. War, conflict and public health task force

Russia's invasion of Ukraine stimulated a renewed requirement to educate ourselves and our students about war, violence, and public health. This has been strongly led for ASPHER by Bielefeld through Oliver Razum, Lisa Wandschneider and Yudit Namer. As Samer Jabour pointed out in our first seminar on Public Health in Times of War series, it should not have taken that conflict to stimulate our concern and action. War continues to be a major cause of poor health, death and disability; it causes prolonged and inter-generational harms to physical and mental health and destroys societies, environments and economies. It also alerted us to the need to understand how weapons of war impact on the human body and influence the need to plan for conflict.

ASPHER's diversity and intersectionality agenda is a key element for prevention of injustice and unfairness, key drivers in themselves for conflict. We will publish this work in the first part of 2023. Our commitment to an ethical framework and values, for public health teaching and practice; not the least of these values is a commitment to peace and non-violence. This will also be published in 2023.

#### 6. Climate change and health education



ASPHER's climate and health education Fellows, Tara Chen and Rana Orhan have been doing brilliant work in the year. We saw climate breakdown first hand, again, this summer; parts of Europe experienced their hottest days ever, and more than 3 Luxembourgs worth of forest fires raged across the continent.

#### Highlights:

Getting the European Health Policy Platform statement on climate change and health education agreed and launched in the European Parliament in May by the ASPHER President. Formal ASPHER launch by Rana as part of the ASSETS event July, and EPH workshop November.

Moving towards the right to 'health for all' by training the public health and wider health workforce on climate change and health: Joint statement by the EU HPP's thematic network "Climate action through public health education and training" statement.

ASPHER is also now a partner in the European Climate and Health Observatory, overseen by EC DGs SANTE and CLIMA. John Middleton chaired the launch of a major report on climate, infectious



<u>disease and heatwave</u> in November and he and Laurent Chambaud, new ASPHER Climate and Health Education Lead, attended the European Observatory meeting in December.

## EUROPEAN PUBLIC HEALTH CONFERENCE - BERLIN 2022


ASPHER office was thrilled to be in Berlin and catch up with members and the wider European public health community for the <u>EPH Conference</u> in November. It was an exciting conference programme keeping us busy with fresh ideas and opportunities to network! We were glad to have the ASPHER booth centrally located to offer a great meeting place of the buzz of activity.



We kicked off the event on Wednesday with a great group of participants for the ASPHER Young Researchers Forum during pre-conferences. <u>Read more about YRF in detail here</u>.

Day one of the conference saw ASPHER President Carlo Signorelli speak on the role of Public Health Institutions and Academia in building capacity for Health Impact Meanwhile Assessment. ASPHER Executive Member and Covid-19 Task Force Chair Nadav Davidovitch contributed to the EUPHA roundtable on Covid-19 pandemic: rise or downfall of Public Health. He brought the considerable experience of the ASPHER Task Force to that event. We wrapped up Thursday with a memorable ASPHER dinner with the Executive Board, WFPHA leadership, ASPHER Fellows, Heads of Berlin SPH and EHESP to celebrate our 2022 ASPHER award winners including Andrija Stampar medalist Laurent Chambaud.

The conversation on greening skills carried over to the roundtable on Climate Crisis & Health Education led by ASPHER Fellows Rana Orhan and Tara Chen with ASPHER's new senior Lead for Climate and Health Education Laurent Chambaud. In parallel, the conversation continued also on digital skills critical to surveillance, communication and knowledge translation as discussed in a round table joined by ASPHER Fellow Rok Hrzic and ASPHER Director Robert Otok.

Finally; we closed out the day and the conference with a round table from the ASPHER COVID-19 Task Force on translating science into policy & lessons learned. 

# Planetary Health Education in Public Health Curricula: A European Perspective - Oral Poster Presentation

ASPHER Fellow Karl Conyard, University College Dublin presented the poster 'Planetary Health Education in Public Health Curricula: A European Perspective; The Association of Schools of Public Health in the European Region' at two recent conferences. The poster is based on one piece of the ongoing update to ASPHER Core Curriculum that Karl is working on under the direction of ASPHER Executive Board Member Mary Codd, UCD.

## Seminar Series (Part II): Public Health in Times of War





# Seminar Series - Part II Public Health in Times of War

War in Europe was widely perceived as a problem of the past. Consequently, European Schools Public Health have taught little about war and its consequences for population health. This has changed with Russia's invasion of Ukraine and the accompanying war crimes against civilians.

This <u>second seminar series on war</u> wrapped up in November with lecturers from the European Region starting to fill gaps in public health curricula which have become obvious since the start of Russia's invasion of Ukraine. When relating to the situation in Ukraine and its neighbours, and when assessing health risks, lecturers have drawn explicit parallels to relevant public health challenges in other world regions, but also to relevant non-war settings.

In the first part of the seminar series, we discussed, for example, how accommodations for refugees are organized (Dr. Joost Butenop & Prof. Dr. Oliver Razum), joint international emergency aid can function in humanitarian crisis (Prof. Dr. Dorit Nitzan, WHO), and how public health can promote peace (Dr. Angelika Claußen, IPPNW).

In the second part of the seminar series, Volodymyr Lotushko (Ukrainian Healthcare Center) showed us how war crimes against medical facilities and personnel can be documented. We also discussed ways in which hate can be conceptualized as a chronic, communicable disease (Prof. Dr. Izzeldin Abuelaish, Dalla Lana School of Public Health) and how (not) to deal with militarism in public health (Prof. Dr. John Middleton, ASPHER).

# Blog: Swords to Ploughshares: The Need to Convert to a Healthier, Greener Economy

The image of the beating of swords to ploughshares outside the UN in New York is a powerful one, created by the Russia Sculptor Yevgeny Vuchetich, early, and deep, in the Cold War. It evokes the book of Isaiah in the Old Testament which says:

'He shall judge between the nations and shall arbitrate for many peoples; they shall beat their swords into plowshares, and their spears into pruning hooks; nation shall not lift up sword against nation, neither shall they learn war anymore'.

Military manufacture is the driver of military adventurism and aggression; it provides the tools for repression. During the widespread opposition to nuclear proliferation in the early 1980s, healthcare workers, under the worldwide aegis of the International Physicians for the Prevention of Nuclear War (IPPNW) campaigned against the threat of nuclear weapons, but also against the waste of money and resources. This was famously captured in Victor Sidel's Lancet paper, 'Destruction before Detonation. More recently, the Stockholm International Peace Research Institute compared the opportunity cost of military spend with the money needed to achieve the UN Sustainable Development Goals; achieving the SDGs 1 and 2, to eliminate hunger, would require 13% of global military spend, SDG4 on education, 12% and SDG 3 on health, 5%.



# The role of public health in the prevention of violence: a statement from the United Kingdom Faculty of Public Health

'Health promotion is peace promotion' – the activity of improving population health inherently strives to reduce inequalities, to achieve fairness, and tackle environmental, economic and social causes of ill health.

Violence is a major public health problem. We believe it has been given insufficient attention and priority in the arena of public health policy, partnerships and interventions. A public health approach to violence prevention involves, measuring health needs arising from violence, determining causes and




solutions to problems, advocating effective interventions and mobilising partnerships to improve health and prevent or control the harmful effects of violence.

These functions, in respect to violence prevention, mitigation and control, apply to all levels of violence – in domestic and local situations, with conflicts between communities, within countries and international violence. This paper sets out the roles of public health practitioners and the role of the public health system in preventing, mitigating and responding to violence.

#### Massive. Brutal. Deliberate: A Report by the Ukrainian Healthcare Center



The destruction of healthcare infrastructure in the Russia-Ukraine war is shocking in its scale and brutality. In the first phase of the invasion (lasting 42 days), Russian troops committed a total of 184 attacks on health facilities, on average four episodes daily. Healthcare infrastructure, including medical personnel, have special protection under international humanitarian law (IHL). Hospitals remain operational even amid active military action to ensure the continuous provision of medical aid to civilians. They are considered protected territory in a conflict, and military forces must take additional precautions to avoid putting health facilities at risk.

This report combines an analysis of the evidence gathered by the Ukrainian Healthcare Center's team from open sources, local witnesses, and site visits.

# ASPHER TASK FORCE ON PROFESSIONALISING THE PUBLIC HEALTH WORKFORCE

The ASPHER Task Force on Professionalising the Public Health Workforce will reconvene in February 2023.

Article: Professionalism of the public health workforce – how to make it happen?

We need a skilled, expert, recognized and regulated public health profession to protect and improve the health of people and the planet. The pandemic has highlighted the need for a strong and multidisciplinary public health workforce (PHW), whose defined professional code is to save lives, protect and improve health. The public and politicians need to have confidence in

the expertise of public health leaders, and they need to be able to put their trust in a group of people with a public health skill set.

The recently launched <u>WHO-ASPHER Road Map to Professionalizing the Public Health Workforce in the European Region</u> sets the direction for international and national public health system-wide action. It proposes actions to advance regulation, structures and solutions for a strong and resilient PHW and to place public health at the forefront of European health policy governance.

The World Health Organization (WHO) has followed this up with a high stakeholder document with a global outlook: <u>Building the public health and emergency workforce</u>: A roadmap. The authors of this important document emphasize that the 'essential role and impact of the workforce involved in delivering public health functions has been overlooked.' Further they recognize that there are many disparities in and across countries and regions concerning PHW policies, capacities, planning or monitoring. It makes it difficult to assess the existing PHW capacities, support and recognize them so that they can deliver essential public health functions to assure health security and improved health and wellbeing.

The two 'road maps' are pointing in the same direction. They highlight an urgent need to strengthen and recognize the PHW. Is professionalization a necessary step forward? Current policy discourse still focuses on numerous barriers and challenges including the definitions, interdisciplinarity and intersectorality of the PHW, which paradoxically can be viewed as its strength on the road to professionalism.

# The ECDC Competency Framework and Self-Assessment Toolkit for Applied Infectious Disease Epidemiology



In 2008 the European Centre for Disease Prevention and Control published core competencies for (ECDC) 'Public Health Epidemiologists working in Communicable Disease Surveillance and Response'. There followed 'Core Competencies for Infection Control and Hospital Hygiene Professionals' (2013); 'Core Competencies for Vaccine-preventable diseases and Immunisation' (2017); and 'Core Competencies on Public Health Preparedness' (2017). The COVID-19 pandemic was the catalyst for updating ECDC core competencies in applied infectious disease epidemiology (UCCAIDE) to capture important developments in diagnostic methods, transmission dynamics, genomic analysis, disease modelling and vaccinology.

A steering group comprising ASPHER (Association of Schools of Public Health in the European Region) Executive Board and COVID-19 Task Force members, ECDC Technical Advisory Group (TAG) and selected experts undertook the updating processes. Agreed updated competencies were published in April 2022 and translated into all European languages. The framework consists of 157 competencies organised in 23 domains, mapped to 6 subject areas (A-F) as follows: A: Essential methods for applied infectious disease epidemiology (4 domains /28 competencies); B: Preparedness, surveillance and response to infectious disease outbreaks (3 domains /29 competencies); C: Communication and advocacy (4 domains /25 competencies); D: Practice of infectious disease epidemiology (5 domains /34 competencies); E:Contextual influences on infectious disease management (4 domains /21 competencies); and F: Leadership and management (3 domains /20 competencies).

To facilitate use of the competency framework, a <u>self-assessment tool (S-AT)</u> developed by ECDC permits individuals to analyse their proficiency level in each domain and to access training resources if desired. At the Winter Scientific Meeting of the Faculty of Public Health Medicine in Ireland, the Project Scientific Lead, Mary Codd, presented preliminary results of a pilot project of its application in an MPH class which highlighted the strengths and limitations

of the tool, and proposed an adaptation to allow capture of proficiency levels of respondents anonymously. It would also facilitate assessment of proficiency before and after delivery of educational programmes. Completion of the S-AT at key points in public health education programmes can identify areas in which programmes perform well and areas for which curricular content could be enhanced. It is hoped that more detailed findings will be accepted for presentation at the World Congress of Public Health (WCPH) in Rome in May 2023.



# Editorial: «I Do Not Have Time» — Is This the End of Peer Review in Public Health Sciences?



The explosion in COVID-19 research caused an unprecedented increase in submissions and thus demand for peer review in health science journals. The publication rates of all peer reviewed public health related articles increased by 25% from 2019 to 2020, and by 21% from 2020 to 2021.

The growth in publications has brought the peer review system to the edge, as the commitment of scientists did not keep pace with the increase in manuscripts. In Elsevier's health and medical journals the increase in peer review invitation acceptances from 2019 to 2020 (February to May periods) was about 50% lower than the increase in submissions. The records of IJPH provide sobering facts, too. "I do not have time" has become a leading response — and even worse: the majority does not respond at all.

The consequences of this crisis are equally bad for our authors and editors. The simple truth is: if we collectively "do not have time" to review manuscripts, there will be no peer review anymore. The editors in chief and managing editor of the International Journal of Public Health (IJPH) and the Public Health Reviews (PHR) — hope you dedicate the time to <u>read this Editorial about the peer review crisis in public health sciences</u>.





## Launch of RCSI School of Population Health

A new School of Population Health launched in October 2022 by RCSI University of Medicine and Health Sciences, Dublin will seek to better understand and address the complex and ever-changing barriers to better health, in Ireland and globally.



The School will build on the university's legacy of impact in population and public health, which can be traced back to the 1840s. The university established a division of population health sciences in 2006 and, more recently, RCSI experts became trusted voices throughout the COVID-19 pandemic.

The School integrates multiple scientific disciplines, including public health and epidemiology, data science, health psychology, healthcare outcomes and global surgery. It will drive multi-disciplinary initiatives in research, develop educational programmes and work with a diverse range of national and global partners to positively impact population health.

Prof. Edward Gregg, inaugural Chair of Population Health at RCSI, said: "We are in a time of great change. The root causes of public health are diverse, and extend beyond genes, biology and medical care, and depend on behaviour, social, economic, environmental and ecologic factors. That is why addressing these challenges requires a multi-disciplinary approach which explores the causes, as well as developing interventions that can make a difference."

The RCSI School of Population Health includes some 70 academic, research and professional staff, as well as 25 PhD scholars. Population health scientists and researchers at RCSI have an impressive, multi-year track record undertaking impactful multidisciplinary research and collaborating with an extensive network of international and national partners.

# Researcher Opportunity: Evaluating the Impact of Dance Resources on Long Covid Symptoms
